# GENERAL CONDITIONS RELATING TO THE GRANDSTAND CHRISTMAS SHOPPING FAYRE 2018

1. The Order Form constitutes a contract and must be signed by the Proprietor, Director, Manager or authorised agent of the company wishing to take part. Completed forms will be binding as an acceptance of liability for the outstanding payment of the stand cost to be paid in full by 27th October 2018. In the event of an exhibitor wishing to cancel their booking for a stand he/she must give the organisers written notice by 27th October 2018 or he/she will be liable to make full payment. In the event of any dispute regarding payment of stand costs the exhibitor agrees for the dispute to be settled at the Barnstaple Court offices. All deposits are non-returnable other than at the complete discretion of the organisers.
2. Save with the organisers prior written consent exhibitors will not be allowed to share, sub-let or transfer any of their allocated space with another company, organisation or individual. Neither shall they be permitted to feature a range of products or services other than those specified on the Order Form without prior notification.
3. Traders shall not display their products in such a manner to obstruct or impede the gangways and the use of public address systems is prohibited. Loudspeaker and similar devices employed in the demonstration of products will only be permitted so long as such use does not cause inconvenience or annoyance to visitors or other exhibitors. Exhibitors are asked to confine their activities to their allocated stand and not impinge on another exhibitor's territory.
4. The organisers reserve the right to expel or to prevent entry by any person whose presence in the event is, in their opinion, prejudicial to the best interests of the event.
5. For the purpose of safety the Westpoint Centre operates a policy of 'no naked flames' on any exhibitors stands and be warned that prior to the event commencing their safety officer will also check for any other potential hazards on any stand. Each exhibitor will need to show they have given due consideration to health & safety at events by completing a 'Risk Assessment' form.
6. Ample free parking is available for all exhibitors but do obey the simple 'where not to park' instructions. We are unable to commence the Fayre even if a solitary vehicle is parked in the wrong area! Display your vehicle pass in your windscreen at all times.
7. The organisers shall not be liable whether in contract, tort or otherwise for any loss or damage whatsoever cause to the property or person of any exhibitor, his sub-contractor or his or their visitors, servants or agents. You must have adequate insurance cover.
8. Traders are responsible for making good at their own expense all damage or dilapidation occasioned by them or their employees or contractors.
9. If exceptional circumstances so require then the organisers reserve the right to alter the published opening hours and other pre-arranged details of the event. Whilst the organisers insure the event against cancellation traders are not covered if the event is cancelled due to certain exclusions (outbreak of war, terrorist actions, quarantine restrictions etc) and traders must insure themselves against loss of stand fees brought about by such events occurring.
10. Exhibitors are required to have completely vacated their stand within 2 hours of the published finishing time of the event unless prior permission has been received in writing from the organisers permitting a delay in removal.
11. Be aware that we do not allow the breaking down of stands and/or removal of stocks from the hall until the Fayre has closed. Offending exhibitors will be banned from taking part in any future Fayres with Grandstand Events Ltd.
12. Exhibitors are responsible for leaving their stands in a tidy condition, all rubbish must be removed prior to stands being vacated. Costs incurred by the organisers in the tidying of stands and removal of rubbish will be passed on to offending standholders
